Information Guide Spring 2014

Dear Prospective Teach Mississippi İnstitute Participant –

Thank you for your interest in the Teach Mississippi Institute Online Program (TMI)! TMI is a MDE-accredited, alternate route program for persons wishing to teach at the secondary level (grades 7-12). It is broken into 2 components, TMI I and TMI 2, both of which are taught online.

TMI 1 (10-week online course) SPRING CLASS BEGINS MARCH 1, 2014

TMI I is a 10-week online course. The online course covers...classroom instruction, effective teaching strategies, classroom management, state curriculum frameworks, planning and instructional methodologies, and use of testing as formative and summative evaluation tools

During the course, students will be required to participate in...online discussions, weekly unit quizzes, weekly written assignments, lesson planning, and...anticipate spending at least 6-8 hours per week on the course.

In addition, students are required to ...

- + complete 60 hours of field experience/observation in a MS secondary school,
- + submit a 500-word reflective summary of the field experience,
- + attend Orientation in Oxford, MS, and
- + attend the Live Seminar in Raymond, MS

Upon completion of TMI I, students will receive a certificate of completion and recommended to the Mississippi Department of Education for their, temporary, non-renewable teaching license.

Once the student has secured a teaching position, he or she may then join TMI 2.

TMI 2 (4.5 month online course & first-year employment) <u>COURSES BEGIN EVERY FALL & SPRING</u>

TMI 2 is a 4.5-month online course taken during the first year of employment. The online course takes an in-depth view into the teaching profession, covering...inclusion teaching, effective classroom management, differentiated instruction, instruction for special needs, ...and more.

During the course, students will continue a similar online course format, including...online discussions, unit quizzes, written assignments, and comprehensive final exam.

In addition, students are required to...

- + attend the Live Seminar in Oxford, MS, and
- + attend the Live Seminar in Raymond, MS

Upon completion of TMI 2, students will receive a certificate of completion for the program and recommended to the Mississippi Department of Education for a 5-year standard, renewable teaching license.

Additional İnformation

Included in this packet are the Spring 2014 TMI application, Praxis information, and financial aid opportunities.

Important Dates

The Spring 2014 TMI I session is March 1 to May 17, 2014

Orientation in Oxford, MS is on **March 1, 2014**. Live Seminar at the Eagle Ridge Conference Center in Raymond, MS is on **May 3, 2014**.

Both Orientation and Live Seminar are MANDATORY for completion of the TMI I online course.





1) Will İ receive college credit for the course?

No, students do not receive college credit for the course.

2) What is the cost of the program?

The cost of tuition for TMI I is currently \$915 which includes the cost of your textbook. The tuition for TMI II is \$1445. The TMI I tuition will be due before orientation begins in order to guarantee your admission to the program. For the second component, the money is due before the component ends and you can utilize a monthly payment plan for the second component.

3) İs financial aid available?

Please refer to the Financial Aid page provided with your packet. You will need to contact your local Win Job Center to inquire about funding under the program title "Alternate Route to Teachers License." For other funding, such as Sallie Mae, follow the instructions on the page.

4) What are critical needs areas and what does that mean for me?

The critical needs areas are math, sciences like biology, chemistry, and physics, foreign languages like French, Spanish, and German, and special education. TMI students who choose to teach one of these subjects are more likely to be accepted to the program and will more easily find a job after the program ends.

5) What is the GPA requirement for admission?

The GPA requirement for admission is 2.5 based on a 4.0 scale. GPAs below 2.5 may be considered for probationary admission.

6) What materials do İ need to turn in to apply, and when are application materials due?

We need from you the application which you can print off of our website, an official transcript from your undergraduate school showing your bachelor's degree, and any official Praxis Core or II score reports that you have. You may have ETS send us your original Praxis scores by giving them our code 1806. Furthermore, your application must include the \$40 nonrefundable application fee, made payable to TMI.

7) How do I submit my Praxis score reports to TMI?

Score reports are no longer mailed to test takers. Please make sure to select the Teach Mississippi Institute (Recipient Code **1806**) when you register for your exams so that we may receive a copy of your scores from ETS. You will view your scores as a locked, Adobe PDF online. Make sure to save a copy of your PDF to your computer as this PDF is your official score report.

8) When will I find out if I've been admitted?

A few days after the application deadline, we will email acceptance and rejection letters to all students who turned in complete applications to us. It is important that the student application indicates a working email address.

9) Can İ be admitted without one or more of the Praxis scores?

Yes, you can be conditionally accepted into the TMI I class without having taken the Praxis tests. This means you can go through the course, but in order to fully complete the course, you must successfully pass Praxis I and II. We strongly recommend that have some of the tests passed before applying.

10) What does the online class cover?

How much time will I have to spend per week on it? The online class covers classroom instruction and application in the fields of effective teaching strategies, classroom management, state curriculum frameworks, planning and instructional methodologies, and use of testing as formative and summative evaluation tools. During the course students will be required to participate in online written assignments and complete online quizzes. Students should anticipate spending 6 to 8 hours on the course every week. In addition to classroom instruction, participants must spend 60 hours in a secondary school setting, gaining hands-on supervised experience. All students in TMI I are required to attend a one day orientation, which will be held on March 1, 2014 in Oxford. Participants will also attend 1 additional live seminar, which will be held on May 3, 2014 in Raymond, MS. More information will be provided on live workshops upon acceptance to the program.

11) When and where do \dot{I} do my sixty (60) hours of field

experience? The sixty hours of field experience must be done in a Mississippi school. You can observe any classroom in grades 7 through 12 even if the subject area being taught is not the subject area you wish to teach. You may begin your 60 hours of field experience as soon as you have been admitted to the program—you do not have to wait until the start of class. Please email tmi@olemiss.edu the following information and we will mail a letter on your behalf to the school or schools of your choice: Name of School, Name of Principal, School Mailing Address, City, State, Zip. Please note that all observations MUST be done in the state of Mississippi and in grades 7-12.

12) What will happen at the end of the first component and at the end of the second component?

Upon successful completion of the first component of TMI I, participants may apply to the Mississippi Department of Education for a non-renewable temporary License and seek employment in a Mississippi public school district (or MDE-accredited private school). Securing an appropriate teaching position is the responsibility of the participant, but the Institute will assist where possible. Successful completion of this year of employment and the second component of the Teach Mississippi Institute, the internship, results in a standard, 5-year renewable Mississippi teacher's license.

13) What grades can I teach when I complete TMI?

Students who complete TMI are able to teach their subject area in grades 7 though 12.

14) Does TMİ assist with job placement or recommendations?

No, not directly. TMI does not place students in schools. In addition, TMI instructors and staff cannot write letters of recommendations for students being the nature of an online course. However, TMI can write letters of good standing or letters of completion that detail your enrollment or completion of the TMI program.

- + Bachelor's degree from an accredited university/college with a minimum 2.5 GPA **OR**
- + Senior-standing within 15 hours of a Bachelor's degree from an accredited university/college with a minimum 2.5 GPA;
- + Passing, *Praxis*[™] Core test scores
- + Passing, *Praxis II*[®] test score in a MS Department of Education-approved subject area* (Please see listing under Praxis Testing Information)
- + Background check with CertifiedBackground.com

Background Check Information

All Teach Mississippi Institute participants must submit for a criminal background check. Applicants must submit their background check request with CertifiedBackground.com after the Teach Mississippi Institute has received their application. When submitting for the background check, make sure to use the Teach Mississippi Institute package code **TB23** to process your order. Background checks cost \$40 and is to be paid to CertifiedBackground.com.



Praxis Information

The Teach Mississippi Institute requires both Praxis[™] Core Content Area tests in Reading, Writing, and Math and Praxis II Subject Area test taken in a Mississippi Department of Education-approved subject area (For a list of all approved subject areas for TMI, please see **Page 6** of your information guide). Please have your scores sent to **Institutional Code - 1806**

ATTENTION: The Mississippi Department of Education (MDE) has changed the requirements for *Praxis I*[®]. Please review pages 5 and 6 of your information guide for more details.

Transcript Information

The Teach Mississippi Institute requires an official copy of your college transcript that shows proof of a Bachelor's degree awarded from an accredited college or university. TMI only requires transcript from the college or university from which you received the Bachelor's degree; we do not require copies of community college or 2-year institution transcripts. However, if you have received a Master's degree, you can submit that transcript to us in addition to the one with the Bachelor's degree. Even if you graduated from the University of Mississippi, you will still need to request a transcript be sent to the TMI Office. Institutions can send transcripts via a e-transcript service to **tmi@olemiss.edu** to the attention of Paige Davis.

ATTENTION: If you have attained Senior status and within one semester of your degree, the TMI Office requires a copy of your transcript to be sent once the degree has been conferred and listed on the transcript.

Conditional Acceptance Information

Students may be granted a one-time conditional acceptance into the Teach Mississippi Institute without having one or more of the above items, excluding the background check requirement. This means a student can start TMI 1 in the semester. However, in order to fully complete TMI 1, conditionally accepted students must turn in the above items to the Teach Mississippi Institute Office by the date specified on their acceptance letter.

EFFECTIVE July 1, 2013: if a student fails to submit the required materials and thus fails the TMI 1 course, they may only be allowed to rejoin TMI 1 after all requirements have been met.

Make sure to select the Teach Mississippi Institute's Recipient Institutional Code (1806) when you register for the Praxis I and II so that our office will receive your scores from ETS.

Save yourself \$30! ETS will no longer mail out official Praxis test scores.

Your official scores will be in a locked Adobe PDF. Make sure to save the "locked" Adobe PDF of your Praxis I and II scores to your computer. Failure to do so will result in having to order scores from ETS for \$30.

Mississippi Department of Education *Praxis*TM Guidelines

The Mississippi Department of Education (MDE) over recent years has made changes to the requirements of ALL teacher education programs. The most recentchange is the replacement of the *Praxis* I[®] content area tests with the new *Praxis*TM Core Academic Skills for Educators tests, also known as *Praxis*TM Core, or CASE by MDE (Praxis Core and the (MDE) CASE are the same test). Below is an explanation of how these recent changes affect current and prospective students of the Teach Mississippi Institute Online Program.

<u>Praxis 1[®] PPST Test</u> - The MDE will accept the **old passing PPST scores** <u>taken before 9/1/2012</u> if the educator took and passed the test before 9/1/2012 and <u>applies for a license by 9/1/2014</u>. This means the educator must have completed the TMI 1 program and have a recommendation by the university.

The PRAXIS I PPST test is a requirement for alternate route educators.

NEW *Praxis*[™] Test: Core Academic Skills for Educators (CASE) (also known as *Praxis*[™] Core by ETS)

The CASE test will begin on **9/1/2013**, BUT the PRAXIS I Pre Professional Skills Test (PPST) will be offered for test takers until 12/31/2013. After 12/31/2013, the PPST PRAXIS TEST will no longer be offered.

The educator CANNOT combine parts of the PPST and parts of the CASE to meet certification requirements.

Beginning 01/01/2014, educators must take and pass the CASE in order to meet certification requirements.

Praxis™ FAQs

How does the Core/CASE test affect me?

If you have not taken or completed all parts of the Praxis I[®] tests, we STRONGLY urge you to take the PraxisTM Core/CASE tests.

If you *completed all parts* of the *Praxis* I^{\otimes} before September 1, 2012, you will need to apply for your temporary license no later than <u>September 1, 2014</u>, OR take the *Praxis*TM Core/CASE tests.*

If you *completed all parts* of the *Praxis I*[®] after September 1, 2012, you will need to apply for your temporary license no later than <u>September</u> 1, 2015, OR take the *Praxis*TM Core/CASE tests.*

*Please note that we advise our TMI 1 students not apply for the license until they have secured a full-time teaching position in a Mississippi school. If you do not take the *Praxis*TM Core/CASE tests, you must secure a teaching position no later than Fall 2014 or Fall 2015, respectfully.

Can İ still be admitted to TMİ without already taken the Praxis Core/CASE tests?

Yes, you can be conditionally accepted into the TMI program without passed the Core/CASE tests. However, tests must be completed by **April 18, 2014**. If you are unable to complete the tests by this deadline, you can extend your course by an additional three months (See Page 4). Please contact the TMI Office for further details.

Notes:

- + The application must include a handwritten signature.
- + The non-refundable \$40 application fee should be made payable to The University of Mississippi/TMI.
- + Applicants must submit to a background check. Applicants will receive notification of their acceptance into the program after the TMI Office receives the background check results. The background check is administered through Certified Background Check. Applicants will receive instructions from Certified Background via email after they submit their signed application and app fee to the TMI Office. The \$40 background check fee IS TO BE PAID TO THE BACKGROUND CHECK COMPANY.
- + The transcript from your degree granting institution must be submitted via electronic e-script (if your institution offers it) to tmi@olemiss.edu or sealed envelope bearing the seal or signature of the registrar. If sent by mail, you can either:
 - Ask the institution to mail your transcripts to the TMI office, **OR**
 - Ask the institution to mail your transcripts to you, and may be stamped "student issued." If you select this method, do not open the sealed envelope!
- + Test scores must be submitted as originals. Please make sure to select the Teach Mississippi Institute Recipient Code (1806) when you register for your Praxis exams OR e-mail your Official Adobe locked PDF of your Praxis scores to **tmi@olemiss.edu**. No printed copies will be accepted.

*Students may be conditionally accepted into the program and begin coursework prior to passing the Praxis Core and/or Praxis II. However, students will not be allowed to complete TMI I without providing passing Praxis scores.

All students in the TMI program must attend the **MANDATORY** Orientation on **March 1, 2014** in Oxford on The University of Mississippi campus. There will be **NO EXCEPTIONS** granted.

The next TMİ 1 class begins March 1. Deadline to apply **February 7**.

As an applicant to the Teach Mississippi Institute,

You are eligible to apply for various financial assistance opportunities.
